

Terms & Conditions (Waiver)

Please sign to indicate your agreement to each of the following:

1. I agree not to participate unless I am medically and physically able, which I am solely responsible to determine.
2. I assume all risks associated with participating in the Battle on the Creek, including, but not limited to, slips, falls, contact with other participants, negligent or wanton acts of other participants, any defects or condition of premises, or the effects of the weather including high heat, cold temperatures, storms and/or humidity. All such risks being known, assumed and appreciated by me.
3. I agree that Special Olympics Georgia/ Battle on the Creek is not responsible for any personal items or property that are lost, stolen, stained or damaged at or during the event.
4. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This Assumption and Release extends to any liability arising out of, or in any way connected with, the medical treatment and transportation provided in the event of an emergency.
5. I grant permission to Special Olympics Georgia/ Battle on the Creek its affiliates and sponsors to use any photographs, motion pictures, recordings or any other record of this event for any purpose including, but not limited to, promoting, advertising and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of Special Olympics Georgia/ Battle on the Creek.
6. I understand that all entries are final with no refunds.
7. The official event directors reserve the right in any event of emergency or local or national disaster to cancel the race and in the event of cancellation or change there is no refund of entry fees.
8. I agree to indemnify Special Olympics Georgia/ Battle on the Creek, its affiliates and assigns, from any and all third party claims caused in whole or in part by my actions.
9. I assume risk of wild animals and insects that may be present on the course.
10. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. Special Olympics Georgia/ Battle on the Creek may dismiss, without refund, anyone whose behavior endangers safety or negatively endangers safety or negatively affects a race, a person, a facility, or property of any type or kind.
